"HOME FOR THE HOLIDAYS" OFFICIAL CONTEST RULES

HOME FOR THE HOLIDAYS will begin Thursday, November 1, 2018, and end on Sunday, November 25, 2018, at 11:59pm EST.

Savannah/Hilton Head International Airport's Home for the Holidays program is presented in partnership with iHeartMedia Savannah, WTOC and the Savannah Area Chamber of Commerce Foundation.

HOW TO ENTER:

To participate in the Home for the Holidays program, simply submit a short letter with a *minimum* of 300 words explaining why your service member should be selected to fly back home to the Savannah/Hilton Head area to spend time with their family over the holidays. Service members are also eligible to nominate themselves.

You can submit your letter for the Home for the Holidays contest by filling out the online form at flySAV.com, or entries may be mailed to: Home for the Holidays, Savannah Airport Commission, Attention: Contest, 400 Airways Ave, Savannah GA 31408. Include your name, address, telephone number, and email address. Also include the service member's name, rank, location/station, airport they would depart from, dates of travel requested, email address, and telephone number.

Online entries will be accepted until Sunday, November 25, 2018 at 11:59pm EST. Mail entries must be postmarked no later than Saturday, November 24, 2018.

Internet entries will be deemed as submitted by the authorized account holder of the e-mail address at the time of the entry. The authorized account holder is the natural person who is assigned to the e-mail address by an Internet access provider, on-line service provider, or other organization that is responsible for assigning email addresses.

For entries submitted by mail or Internet, the Savannah Airport Commission is not responsible for lost, stolen, mutilated, misdelivered, postage-due, illegible, or untimely entries; difficulty accessing the Internet; service outages or delays; computer difficulties; or other technological glitches.

ELIGIBILITY RESTRICTIONS:

This program is open to all residents of the Savannah/Hilton Head service area. The service area is defined as Appling, Brantley, Bryan, Bulloch, Chatham, Effingham, Emanuel, Glynn, Jenkins, Jeff Davis, Liberty, McIntosh, Montgomery, Pierce, Screven, Telfair, Truetlen, Wayne, and Wheeler counties of Georgia and Allendale, Bamberg, Barnwell, Beaufort, Colleton, Hampton, and Jasper counties of South Carolina.

Employees of the Savannah Airport Commission or employed at the Savannah/Hilton Head International Airport and their immediate families are ineligible. Immediate family is defined as: parents, children, in-laws, spouses, those in spouse-like relationships, and siblings including those in step and half relations living in the same household.

Only one entry per service member per household is allowed. Service members can nominate themselves. Service members must be on active duty or be full-time guard members, rank E6 or below, and also be eligible for leave. Travel must be made between December 1, 2018, and January 31, 2019. Inability to travel on these dates will forfeit eligibility. Eligibility must be determined within fourteen (14) business days from selection. If the winning entry is deemed ineligible, another entry will be selected and the process will continue until each trip is awarded. If all entries are deemed ineligible, no prize will be awarded.

HOW TO WIN:

All entries will be read by a committee. Seven entries will be selected for either domestic and/or international travel based on emotional appeal, family story, and service member's ability to travel between December 1, 2018, and January 31, 2019.

Each winning service member will receive one (1) free round-trip economy class ticket to Savannah, GA from anywhere the service member is stationed *or* from Savannah, GA for service members stationed in the area. Tickets are not transferable and may not be substituted for or redeemed for cash.

Approximate value of the trip granted will vary depending on the location of the service member and the dollar amount of the ticket on the date ticket is issued.

Winning entries will be selected by Friday, November 30, 2018, and announced on participating iHeartMedia Savannah stations and WTOC no later than Friday, December 7, 2018.

CONDITIONS:

By participating in Home for the Holidays, the winner(s) agree(s) to allow their name, voice, and/or likeness to be used in any advertising, social media platform, or broadcasting material relating to Home for the Holidays without additional financial or other compensation.

Each winner must provide proper military identification to the Savannah Airport Commission and sign a receipt verifying eligibility prior to acceptance of any prize.

The Savannah Airport Commission at its sole discretion, reserves the right to disqualify any person tampering with the entry process, the operation of the Savannah/Hilton Head International Airport website, or who is otherwise in

violation of the rules. The Commission further reserves the right to cancel, terminate, or modify the contest if it cannot be completed as planned, for any reason including but not limited to infection by computer virus, bugs, tampering, unauthorized intervention, or technical failures of any sort.

These rules are subject to the sole interpretation of the Savannah Airport Commission.
