# METHODOLOGY for Establishing the FY 2024 – FY 2026 Overall Disadvantaged Business Enterprise (DBE) Goal for:

## SAVANNAH/HILTON HEAD INTERNATIONAL AIRPORT Savannah, Georgia

In fulfillment of the requirements of 49 CFR Part 26, the Savannah Airport Commission (hereafter 'the Airport Commission') has developed a proposed Overall Goal for FY 2024-2026 FAA-AIP projects for the Savannah/Hilton Head International Airport. The methodology used in establishing this goal is described herein.

## I. Detailed Methodology: Specific Steps

## A. Amount of Goal

The Airport Commission's FY 2024-2026 overall goal for the Federal financial assistance it will expend in USDOT-assisted contracts is the following:

Overall Goal:	11.39%
Race-Neutral:	<u>0.30%</u>
Race-Conscious:	11.09%

Given the amount of USDOT-assisted contracts that the Airport Commission expects to let from FY 2024-2026, which is approximately **\$103,496,830** this means that the Authority has set a goal of spending approximately **\$11,792,236** with DBEs during this period.

## B. Determination of the Market Area of the study

The normal market area was based on discussions with the Airport Commission staff and an assessment of bidders from similar recent projects. Specifically, the market area is based on where the substantial majority of bidders, both successful and unsuccessful, are located as illustrated in **Table 1** below. A number of bidders had very small portions of work and were from other states. Consultation with the staff led to an agreement that the following counties comprised the primary market area.

# D. Determination of Relative Availability of DBEs in Market Area, Compared to all Firms:

After the upcoming projects have been determined, along with breakdowns of major NAICS codes for each fiscal year, the next step in the goal setting process is to develop a base figure, or Step 1 goal. The Step 1 goal is based on some type of analysis of "relative availability", i.e. the availability of DBE's and/or potential DBE's in the market area, to work on those projects, compared to ALL firms potentially available to work on those projects, in the same market area. In this approach, the primary data sources are the U.S. Census Bureau, County Business Patterns, for "all businesses", and the Georgia Unified Certification Program (UCP) directory for DBE firms in those market area counties. The relative DBE availability percent derived for each major trade/NAICS code, is multiplied by the percentage of dollars in that trade/NAICS, to yield a "weighted" DBE dollar amount. In the end, all of the DBE dollars are added together and calculated as a percentage of the total dollars for all of the projects, to yield the "final" Step 1 goal, or base figure. The results are shown in the series of Tables 3a, through 3j.

NOTE: The County Business Patterns data were used as the source to determine the denominator, or the number of all firms in the market area. The DBE directories listed above were used to determine the numerator, or the number of DBE firms in the market area.

## E. Determination of the "Weighted" DBE Base Figure

As noted in D., above, the Step 1 DBE Base Figure for each project was derived by multiplying the dollars for each activity by the percentage of relevant DBE firms to all relevant firms.

The total DBE goal in dollars was divided by the total project costs to derive the individual Step 1 goals for each of the 10 projects for FY 2024-26. These are shown in Table 4, below:

## II. Adjustments to the DBE Base Figure

After the DBE Base Figure has been developed, the regulations (49 CFR Part 26) require that:

## A. Adjustment Factors to Consider

The regulations further state that there are several types of evidence that must be considered when adjusting the base figure. These include:

"(i) The current capacity of DBEs to perform work in your USDOT-assisted contracting program, as measured by the volume of work DBEs have performed in recent years.

<sup>&</sup>quot;...additional evidence in the sponsor's jurisdiction be considered to determine what adjustment, if any, is needed to the base figure in order to arrive at your overall goal" (26:45(d)).

The historical overall DBE goals accomplished at the Airport in recent years were examined relative to the above consideration. Notice the annual DBE percent accomplishment indicated in Table 5 below:

The median DBE accomplishment for the periods as shown above for the Airport Commission is **10.90%**.

### **B.** Consultations

The Airport Commission held a virtual public meeting on **August 8, 2023**. The purpose of the meeting was to solicit information from interested stakeholders about the draft goal, as well as the availability of potential DBEs at the Airport, the effects of discrimination on opportunities for DBEs, and the Airport Commission's effort to increase DBE participation. Please see Appendix A for the attendee list and public comments.

A total of 13 people attended the August 8 meeting. The attendees consisted of a mix of DBE businesses, Airport Commission staff, representatives of other compliance programs (e.g., City of Savannah) and the SAV DBE consultant team (see the attendee list in Appendix B).

At the meeting, the consultants reviewed in detail the methodology, showing how the final proposed new triennial DBE goal was derived. Afterwards, the floor was open for questions. There was little additional discussion. A question/answer summary is shown in Appendix B.

# C. Adjustment to Step 1 DBE Base Figures: Savannah/Hilton Head International Airport, FY 2024 - FY 2026

After calculating a base figure of the relative availability of DBEs, evidence was examined to determine what, if any, adjustment to the base figure was needed to arrive at the overall goal. The median of historical DBE accomplishments, as shown above in Table 5, was used to determine the adjustment to the base figure. The median DBE accomplishment for FY2018-FY2022 is **10.90%**.

To arrive at an overall goal, the Step 1 base figure was added to the Step 2 adjustment figure and the total was averaged, arriving at an overall goal of **11.39%**. The Airport Commission believes this adjusted goal accurately reflects DBE participation that can be achieved for the types of work being awarded for FY2024 – FY2026.

#### III. Process

The Airport Commission normally submits its overall goal to the FAA on or before August 1 of each goal period.

Before establishing the overall goal this year, the Airport Commission consulted with minority, women's and general contractor groups, community organizations, and other officials or organizations to obtain information concerning the availability of disadvantaged and non-disadvantaged businesses, the effects of discrimination on opportunities for DBEs, and the Airport Commission's efforts to establish a level playing field for the participation of DBEs.

Following this consultation, the Airport Commission published a notice of the proposed overall goal on its website informing the public that the proposed goal and its rationale were available for review and comment during normal business hours by contacting the DBELO. The notice included appropriate email addresses to which comments could be sent and addresses where the proposal could be requested. This process was used to establish the goals for FY 2024 through FY 2026.

The Airport Commission's overall goal submission to the FAA will include a summary of information and comments received during this public participation process and our responses.

The Airport Commission will begin using the overall goal on October 1 of each year, unless the Airport Commission has received other instructions from DOT/FAA (or, if the goal is established on a project basis) by the time of the first solicitation for a DOT/FAA-assisted contract for the projects.

## IV. Breakout of Estimated Race-Conscious/Race-Neutral Participation

The Airport Commission will meet the maximum feasible portion of its overall goal by using race-neutral means of facilitating DBE participation. The Airport Commission will use a combination of the following race-neutral means to increase DBE participation:

1. Arranging solicitations, times for the presentation of bids, quantities, specifications, and delivery schedules in ways that facilitate DBE, and other small businesses participation (e.g., unbundling large contracts to make them more accessible to small businesses, encouraging prime contractors to subcontract portions of work that they might otherwise perform with their own forces);

2. Disseminating information communications on contracting procedures and specific contract opportunities (e.g., ensuring the inclusion of DBEs, and other small businesses, on recipient mailing lists for bidders, ensuring the dissemination to bidders on prime contracts of lists of potential subcontractors).

The Airport Commission proposes a race-conscious goal of **11.09%** and a race-neutral goal of **0.30%**, for a total of **11.39%**. The reason for this breakout is that the projects from the previous year's show that the median amount by which the past DBE goals were over-achieved is **0.30%** (see **Table 5**).

The Airport Commission will adjust the estimated breakout of race-neutral and race-conscious participation as needed to reflect actual DBE participation (26.51(f)) and it will track and report race-neutral and race-conscious participation separately. For reporting purposes, race-neutral DBE participation includes, but is not necessarily limited to, the following: DBE participation through a prime contract a DBE obtains through customary competitive procurement procedures; DBE participation through a subcontract on a prime contract that does not carry a DBE goal; DBE participation on a prime contract exceeding a contract goal; and DBE participation through a subcontract from a prime contractor that did not consider a firm's DBE status in making the award.

### V. Contract Goals

The Airport Commission will use contract goals to meet any portion of the overall goal that it does not project being able to meet using race-neutral means. Contract goals are established so that, over the period to which the overall goal applies, they will cumulatively result in meeting any portion of our overall goal that is not projected to be met through the use of race-neutral means.

The Airport Commission will establish contract goals only on those DOT-assisted contracts that have subcontracting possibilities. The Airport Commission need not establish a contract goal on every such contract, and the size of contract goals will be adapted to the circumstances of each such contract (e.g., type and location of work, availability of DBEs to perform the particular type of work).

The Airport Commission will express its contract goals as a percentage of the Federal share of a DOT-assisted contract.
